Service Application and Agreement :

All water shall be metered by meters to be furnished by the CITY OF WASKOM. TO be located within the STATE OF TEXAS. The meter and / or wastewater connection is for the sole use of the CUSTOMER and is to provide service to only (1) dwelling or (1) business. Extension of pipe (s) to transfer utility service from one property to another, to share, resell or submeter water to any other persons, dwellings, businesses, or property, water or sewer services in other states etc.. is prohibited.

It is the customer's sole responsibility, and not the responsibility of the CITY OF WASKOM to any extent, to ensure at the time water service is initiated at the customer's location that there are no leaks, broken pipes, faucets left on or other similar circumstances that could result in water damage or water loss. Any damage of any loss water loss resulting from such shall be borne sole and exclusively by the customer and not the CITY OF WASKOM.

The CITY OF WASKOM shall have the right to locate a water service meter and the pipe necessary to connect the meter on the CUSTOMER'S property at a point to be chosen by the CITY OF WASKOM, and shall have access to its property and equipment located upon CUSTOMER'S premises at all reasonable and necessary times for any purpose connected with or in the furtherance of its business operations, and upon discontinuance of service the CITY OF WASKOM shall have the right to remove any of its equipment from the CUSTOMERS property. The CUSTOMER shall install at their own expense any necessary service lines, isolation valves or sanitary sewer clean-outs from CITY OF WASKOM'S facilities. other equipment as may be specified by the CITY OF WASKOM. The CITY OF WASKOM shall also have access to the CUSTOMER'S property for the purpose of inspecting for possible cross - connections and other undesirable plumbing practices. Upon completing the service inspection the City has the authority to have customer install at the customers expense a suitable back-flow device, customer will be responsible for installation, maintaining, and testing of said equipment. The City Of Waskom will maintain records of such equipment.

The CITY OF WASKOM is responsible for protecting the drinking water supply from contamination or pollution which could result from improper plumbing practices. This service agreement serves as notice to each customer of the plumbing installation of an air gap if a possible cross-connection exist.

- a) No direct connection between the public drinking water supply and a potential source of contamination is permitted. Potential sources of contamination shall be isolated from the public water system by an air-gap or an appropriate backflow prevention device.
- b) No cross-connections between the public drinking water supply and a private water system is permitted. These potential threats to the public drinking water supply shall be eliminated at the service connection by the installation of an air-gap or a reduced pressure-zone backflow prevention device.
- c: No connection which allows water to be returned to the public drinking water supply is permitted.

d: No pipe or pipe fitting which contains more the 0.25% lead may be used for the installation or repair of plumbing at any connection which provides water for human use.

e: No solder or flux which contains more than 0.2% lead can be used for the installation or repair of plumbing at any connection which provides water for human use.

f. The CITY OF WASKOM shall have the right to discontinue a water service if the CUSTOMER has sewer problems, and will not be re-connected until problem is solved.

g. The CITY OF WASKOM will not be responsible for clothing stained due to upsets in water service.

The CITY OF WASKOM shall maintain a copy of this service agreement as long as the CUSTOMER and / or premises is connected to the public water system. The CUSTOMER shall allow his property to be inspected for possible cross-connections and other undesirable plumbing practices. These inspections shall be conducted by the CITY OF WASKOM or its designated agent prior to initiating service and periodically thereafter. The inspections shall be conducted during the CITY OF WASKOM'S normal business hours. The CITY OF WASKOM shall notify the CUSTOMER in writing of any cross-connections or other undesirable plumbing practices which have been identified during the initial or subsequent inspection. The CUSTOMER shall immediately correct any undesirable plumbing practice on their premises. Failure to comply with the terms of this service agreement shall cause the CITY OF WASKOM to terminate service until all violations are corrected. Any expenses associated with the enforcement of this agreement shall be billed to the CUSTOMER.

By execution hereof, the Applicant shall hold the CITY OF WASKOM harmless from any and all claims for damages caused by service interruptions due to waterline breaks by utility or like contractors, tampering by other CUSTOMERS/ users of the CITY OF WASKOM, normal failures of the system, or other events beyond the CITY OF WASKOM'S control.

The CUSTOMER shall grant to the CITY OF WASKOM, now or in the future, any easements of right-of-way for the purpose of installing, maintaining, and operating such pipelines, meters, valves, and any other equipment which may be deemed necessary by the CITY OF WASKOM to extend or improve service for existing or future CUSTOMERS, on such forms as are required by the CITY OF WASKOM.

By execution hereof the Applicant shall guarantee payment of all rates, fees, and charges due on any account for which said applicant owns a Service Agreement. Said guarantee shall pledge any and all CUSTOMER fees against any balance due to the CITY OF WASKOM liquidation of said fees shall give rise to discontinue service.

By execution hereof, the Applicant agrees that non-compliance with the terms of this agreement by said Applicant shall constitute denial or discontinuance of service until such time as the violation is corrected to the satisfaction of the CITY OF WASKOM.

Any misrepresentation of the facts by the Applicant on any of the pages of this agreement shall result in discontinuance of service pursuant to the terms and conditions of the CITY OF WASKOM.

WELCOME TO WASKOM:

In order to help make Waskom a pleasant place to work and live, there are a few ordinances designed to help keep our city safe, clean and enjoyable. We hope the following will help everyone understand a little of each ordinance and to know that they do exist.

ORDINANCE #51

Requires the connection to the sanitary sewer system of all fixtures discharging wastewater.

ORDINANCE #81

All dogs and cats over 4 months of age must be vaccinated against rabies.

Dogs must be under the control of the owner or person harboring it at all times (harboring means that if you feed and care for an animal, then you are responsible for it).

Continuous noises such as barking and crying are also a violation of this ordinance.

Report all animal bites.

SECTION 7.1 ORDINANCE #81

"PROHIBITED ANIMALS"

It is unlawful for any person to import, offer for sale, keep, maintain, harbor or permit in the City of Waskom any monkey, or other non-human primate, skunk, raccoon, jaguar, leopard, lynx, tiger, lion, ocelot, bobcat, cheetah, mountain lion, wildcat, panther, bear, wolf, coyote, fox or other carnivorous animal or poisonous reptile, and any hybrid. Also chickens, turkeys, ducks, geese, guinea fowl and related poultry birds.

SECTION 7.3 ORDINANCE #81

You can have up to six (6) chickens which are maintained and kept solely for school approved projects and which projects have been verified in writing as "approved" by an authorized faculty or administration representative of an accredited public or private post-elementary school.

ORDINANCE #98

Defines and regulates abatement and removal of junked vehicles, appliances and other debris.

If a vehicle is inoperable, wrecked or partially dismantled, or discarded, does not have valid registration, is defined as junk.

ORDINANCE #114

Requires every household, business, apartment, dwelling, church, or other entity within the city to be on solid waste pickup.

ORDINANCE #144-1

Permits burning on Monday, Thursday and Saturday between the hours of 7am and 7pm (IF there is not a burn ban in place). ONLY leaves, pine straw and tree trimmings can be burned.

ORDINANCE #148

Regulates weeds, brush, rubbish and any other objectionable, unsightly, or unsanitary matter of whatever nature. Weeds cannot be higher than 12 inches, un-kept brush under 7 feet and rubbish including useless articles and discarded clothing and other clutter are violations of this ordinance.

ORDINANCE #168

This ordinance covers livestock. It is unlawful for any person to keep or maintain, or permit to be kept or maintained, on premises owned by him or under his control, a horse, cow, goat, mule, donkey, sheep or any like animal, unless eight thousand (8,000) square feet or open space is provided for each such animal, and further provided (1) no part of such open space shall be located within fifty (50) feet of any residence, commercial building, or industrial building; and (2) no part of any shed, stall, lean-to, feeding device, watering device, nor any structure for the care, feeding or maintenance of any such animal shall be located within one hundred (100) feet of any residence, commercial building or industrial building.

ORDINANCE #185

Curfew for persons age 16 and under is as follows:

11:00pm to 6:00am Sunday – Thursday

12:01am to 6:00am Friday and Saturday

ORDINANCE #242

Requires removal of solid waste receptacles from curbside locations. It shall be unlawful for any person to maintain any trash receptacle curbside within the City of Waskom later than 6:00pm on the day after the most recent residential or commercial pick-up and removal of solid waste is schedule for such property or location within the City: (Example only: if trash pick-up is Thursday, you must have your receptacle picked up from the curb by Friday 6:01pm.)

ORDINANCE #280

This ordinance covers construction/building permits. Any person, firm, or corporation must give notice of any development addition to, substantial improvement or construction to any existing structure prior to beginning such construction to any residence within the City by requesting or obtaining a valid construction/building permit from the City of Waskom. No person, firm or corporation shall locate, move onto or add any manufactured permanent structure (including but not limited to mobile homes or manufactured storage buildings) to any real property within the City without first giving notice of such intended construction or addition to the City by requesting and receiving a valid building/construction permit from the City of Waskom prior to commencement of such intended construction.

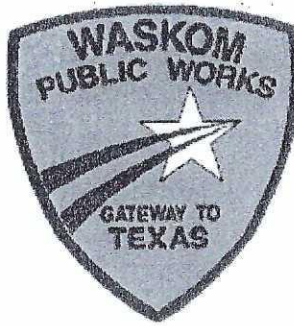
ORDINANCE #319

This ordinance prohibits multiple connections to one meter, or multiple connections on sewer taps. Violations of this ordinance is punishable by a fine up to \$100.00 per day.

ORDINANCE #320

This ordinance prohibits the occupancy of any structure intended for the purpose of a residence which does not have an active water service. Violations of this ordinance is punishable by a fine of up to \$250.00 per offence.

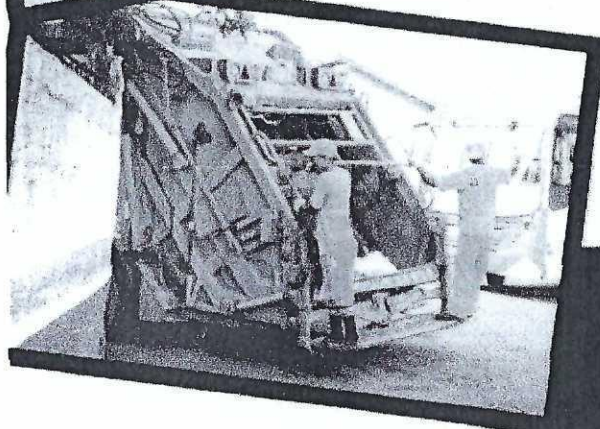
